Dear Northborough Water Customer;

Northborough is again joining the other MWRA communities in providing our water users with the Annual Water Quality Report produced by the MWRA. For calendar year 2010, 80% of Northborough's water has been pumped from the MWRA system. The balance comes from the Lyman Street well which has been online with appropriate treatment since 2009.

After pumping the water from MWRA and the Lyman St well, Northborough is responsible for delivering the water to our customers. MWRA's water receives complete treatment. MWRA adds fluoride, which is done to prevent tooth decay/cavities. The Water Division maintains over 70 miles of distribution pipelines, over 550 fire hydrants and services 4,084 accounts. In 2010, the Town of Northborough Water Department distributed 330 million gallons of water to Northborough customers. As part of the Department's routine maintenance program, the Department flushes the entire system to remove sediment and other debris. Additionally, we perform leak detection semi-annually.

IMPROVEMENTS

The Water Department is evaluating, upgrading, cleaning and lining water mains on an on-going basis. The construction of the new Brigham Street well has been approved by DEP. The Water Department has almost completed replacement of all the outside water readers with radio transmitters inside the house, at the meter. Only 200 meters remain to be replaced. **If you do not already have one, please call the Department at the number above to schedule free installation.**

CROSS CONNECTION

Northborough has an ongoing program to eliminate possible cross connections from the distribution system. A cross connection can happen when water gets suctioned back into the water system by negative pressure which can be caused by using hydrants to fight a fire or a water main break. Any homeowner who has an irrigation well must have it inspected by the Water Department to ensure that there is no cross connection between the municipal water system and the irrigation well. (As always, since June 1985, no irrigation systems can be connected to the municipal water system. All irrigation systems must be connected to a private well.)

WATER ANALYSIS

The Town of Northborough and MWRA continue to analyze water samples on a routine basis and met all standards. Northborough had only a reporting violation during calendar year 2010.

LEAD & COPPER RESULTS

Northborough has conducted lead and copper testing and found that the Action Levels for both lead and copper were met.
